

S.A.F.E. WAIVER & RULES AGREEMENT



In consideration of being allowed to enter the play area and participate in any program or activity at FunDayGo in Florence, SC, the undersigned, on his or her own behalf, and on the behalf of the minor participant(s) identified below, agrees as follows:

1. I represent that I am the parent or legal guardian of the participant(s) named below, or I have obtained permission from the parent/legal guardian of the participant(s) named below to execute this agreement on their behalf. I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for participation in any party and/or program at FunDayGo. In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest FunDayGo employee or official immediately.

2. I understand that there are inherent risks associated with participation in FunDayGo activities and use of the play area and inflatable equipment. On my own behalf and on behalf of the participant(s) named below, I hereby knowingly and freely assume all such risks, both known and unknown, including those that may arise out of the negligence of other participants and/or FunDayGo ownership or employees.

On my own behalf and on behalf of the participant(s) named below, and on behalf of all of our respective heirs, assigns, administrators, personal representatives, and next of kin, I hereby release and hold harmless, FunDayGo, LLC, their affiliates, officers, members, agents, employees, and sponsoring agencies from and against any and all claims, injuries, liabilities, or damages arising out of or related to our participation in any and all FunDayGo activities and use of the play area, party rooms, bathrooms and/or inflatable equipment. I further agree to fully indemnify the parties released herein from any and all claims, damages, costs (including attorney fees), and causes of action which may arise that are related to any of the claims released herein.

Here are S.A.F.E. Rules to assist you in caring for your children:

- Please eat and drink in the designated areas only. There is **NO food, drink, gum, ice cream or candy allowed on the inflatables at any time.** All participants must wear socks and have signed S.A.F.E. Waiver.
- For your safety and others, be responsible and mindful of the people around you. There is **NO running, pushing, wrestling, hitting or rough play allowed.** Please **do NOT flip on the inflatables and do NOT jump down the slides. Slide feet first only and one at a time** when going down our tall slides.
- Always care for others. **NO meanness, NO profanity and NO rude behavior.**
- Have mega fun!

If a child does not follow the rules, the following steps will be taken to ensure other guests are able to enjoy their play time:

1st Offense: A **verbal warning** will be issued by our Play Patrol and the child's wristband will be marked.

2nd Offense: Another verbal warning will be issued by our Play Patrol and the **child's wristband will be marked** and the child's **parent/guardian will be warned** of the second offense.

3rd Offense: The child will be asked to **discontinue playing.** This will **include the possibility of leaving FunDayGo** without reimbursement. Please accept that it is at the sole discretion of the management of FunDayGo who is permitted to play or not play and this decision is final without recourse by the participant and/or the participant's parent/guardian.
